

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <http://www.chiquitodivino.com> and Chiquito Divino and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Chiquito Divino include <http://www.chiquitodivino.com>. The Chiquito Divino website is a ecommerce site. By using the Chiquito Divino website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Chiquito Divino may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Chiquito Divino's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. - SSL Protocol

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
